- Many Blue Ox® Baseplates are designed to use existing holes and hardware to mount the baseplate to the towed vehicle. Even though bolts are there, do not assume they are adequate for baseplate mounting. Always use hardware supplied in the hardware kit or existing hardware specified in the Baseplate Installation Instructions.

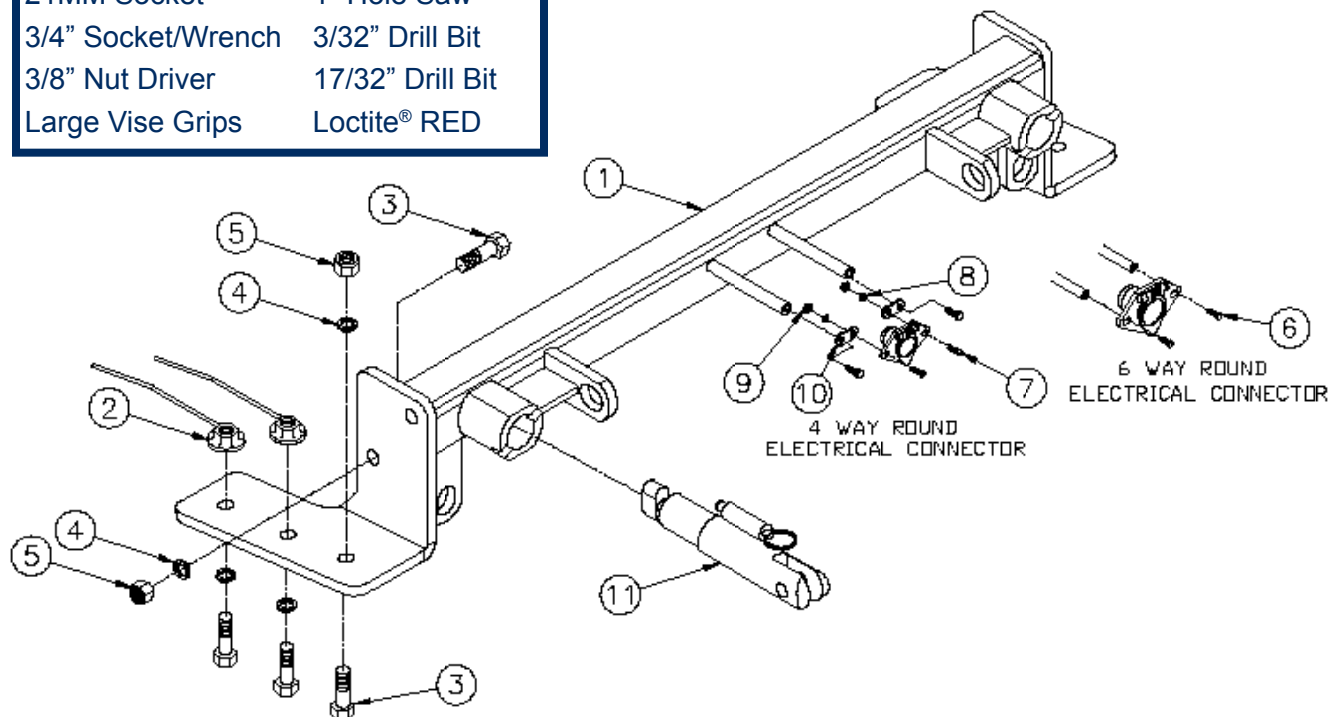

Important:

Use only genuine factory replacement parts on your baseplate. Do **NOT** substitute homemade or non-typical parts. If a bolt is lost or in need of replacement, for your safety and the preservation of your baseplate, be sure to use a replacement bolt of the same grade (In most cases it will be Grade 5, please reference the parts list above). Replacement parts may be ordered through your nearest Blue Ox® Dealer or Distributor.

Attachment Tabs:

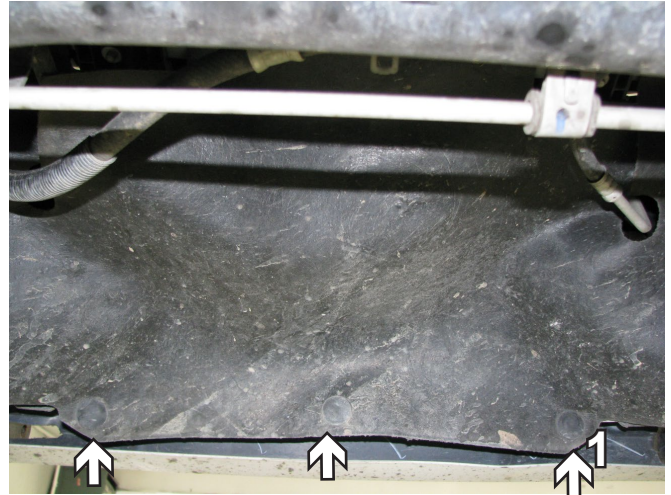
Due to the design of the removable tabs, the RangeFinderII and Ambassador tow bars can not be used. Adapters, except the BX8833 and BX88151, can not be used with this baseplate.

Installation Notes: The grille, front fascia and blinker assemblies are removed and replaced during installation. Drilling is required. The air dam must be trimmed.

The dimensional variations between otherwise identical vehicles can be considerable. While the baseplate was designed for easy installation, it may be necessary to tailor the baseplate slightly to compensate for auto manufacturer's tolerances. These minor adjustments may include filing a hole slightly, bending electrical rods, and/ or bending end plates.

The BX8869 Bulb and Socket Wiring Kit is recommended for this vehicle.

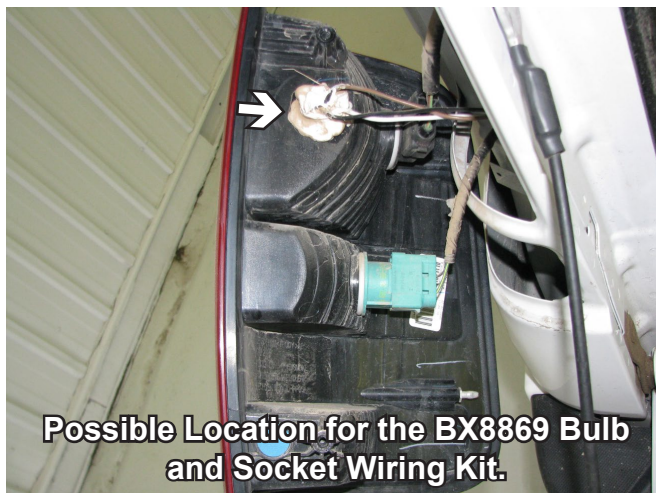
Installation Instructions:



1. Remove three push pins from underneath the front of the fascia. Do this to both sides of the vehicle. Set the pins aside to reinstall later.

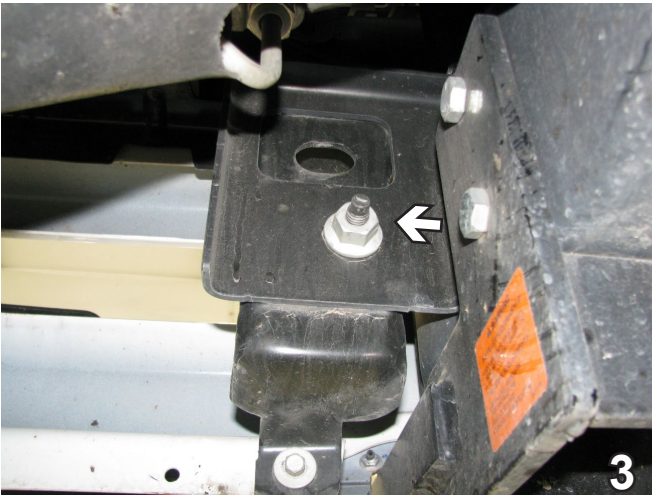


2. Using a 21MM socket, remove two bolts on each side from underneath the plastic. Do this on both sides of the vehicle. Set bolts aside to be reinstalled later.

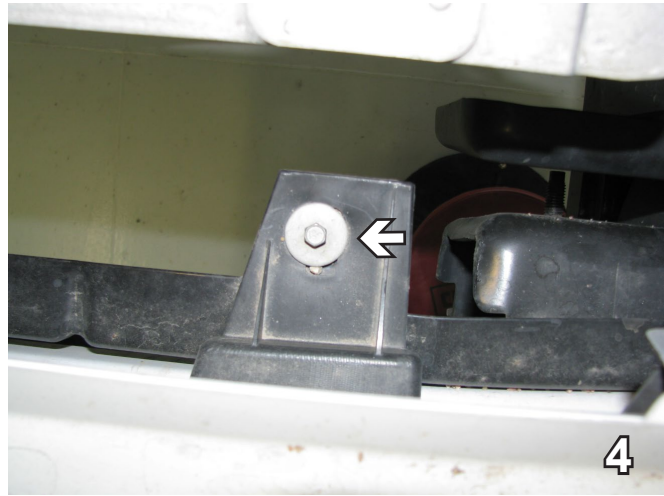


Possible Location for the BX8869 Bulb and Socket Wiring Kit.

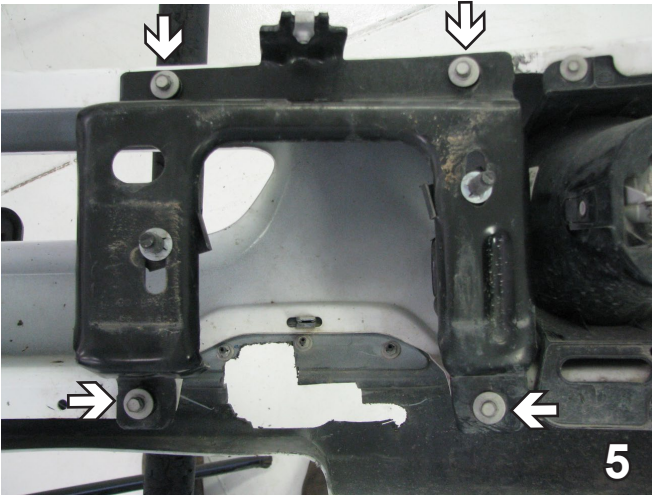

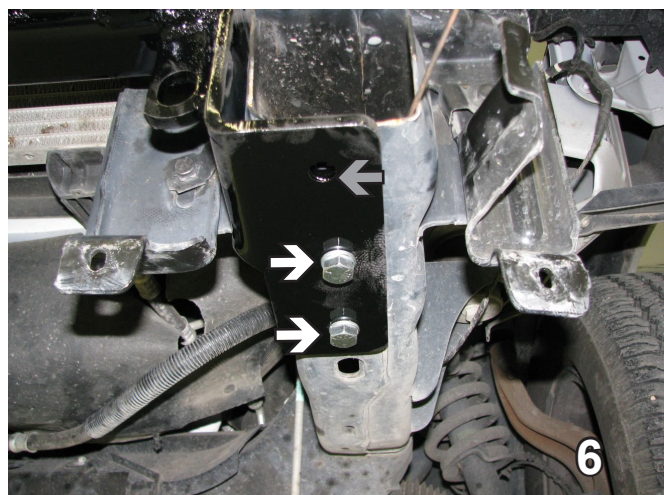
3. Inside the hood, using a 10MM socket remove one bolt on each side. Set bolts aside to be reinstalled later.



4. Using the 8MM socket, remove three bolts just behind the fascia across the front. Remove the fascia and set aside.



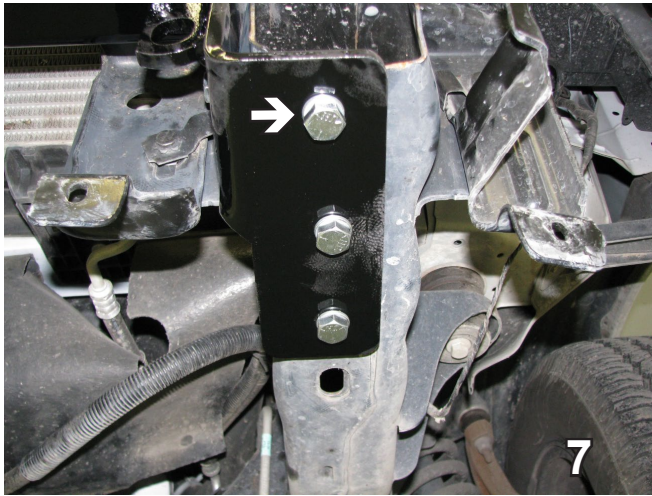
5. On the back side of the fascia, using a 10MM socket, remove the four bolts from the bracket. Do this to both sides. Remount the bracket onto the vehicle for the baseplate to go inside on both sides. Leave the bracket loose until the bumper is back on and in its original position.



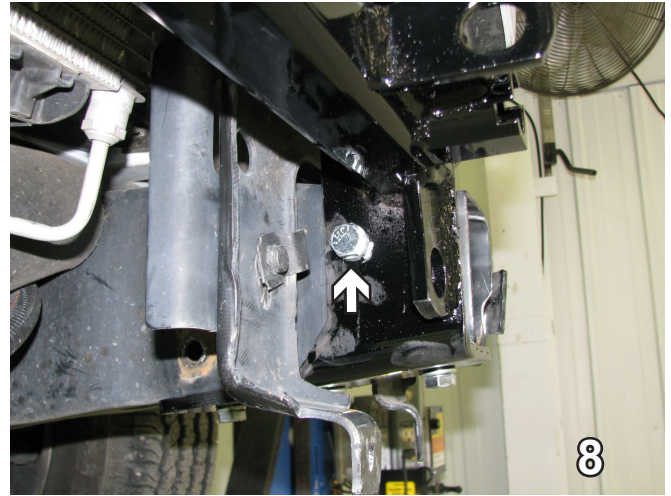
6. Slide the baseplate up, start the two bottom bolts into the existing holes. Use 1/2-13 x 1 3/4" hex bolts with loctite, 1/2" lock washers and 1/2-13 whiz nuts. Using the baseplate as a template, drill the remaining hole (gray arrow). Do this on both sides of the vehicle.

BE SURE TO USE LOCTITE® RED ON ALL BOLTS BEFORE TIGHTENING. TIGHTEN ALL BOLTS ACCORDING TO THE TORQUE CHART ON THE FRONT PAGE OF THESE INSTRUCTIONS OR ON PAGE 3 OF THE BASEPLATE TOWING GENERAL INSTRUCTIONS.

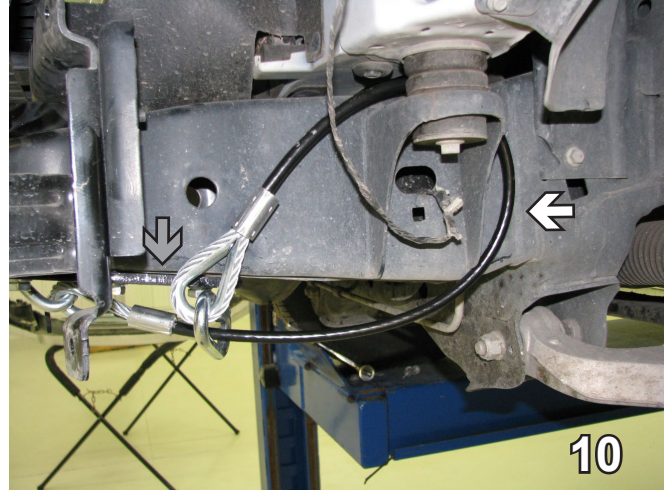
7. Insert 1/2-13 x 1 3/4" hex bolts, 1/2" lock washers and 1/2-13 hex nylon insert lock nuts. Be sure to use loctite. Do this on both sides of the vehicle.



8. On the inside, using the baseplate as a template drill another hole. Attach 1/2-13 x 1 3/4" hex bolts, 1/2" lock washers and 1/2-13 hex nylon insert lock nuts. Be sure to use loctite. Do this on both sides of the vehicle.



9. View of the frame end, showing all the bolts installed.



10. Attach the permanent baseplate safety cables to the provided convenience link on the baseplate (see gray arrow). The photo above shows the recommended installation of the permanent baseplate safety cables to frame of the vehicle (see white arrow). Additional options may interfere with suggested mounting, in this case secure the cables to a solid piece of the frame as described in the instructions included with the permanent baseplate safety cables. Be sure the safety cables do not rub against any hoses or moving parts.

Be sure that **ALL** electrical connections are plugged in properly and functioning **BEFORE** installing the fascia.

11. Replace the fascia, reinstalling all the nuts, pins and screws.

Install the tow bar and safety cables according to the instructions provided in their packages. When demonstrating this to the customer, be sure to include all the contents and packages.

Do **NOT** substitute other devices if the tow bar pins and clips are misplaced.

General Information

1. Ensure that your product(s) are registered online at www.blueox.com. It is crucial to register your product(s) so that you may be alerted of product offerings, updates, upgrades, maintenance and safety bulletins, and/or recalls.
2. **It is the owner's responsibility to inspect all towing equipment for cracked welds, missing or worn parts and loose bolts before each towing trip.** Be sure to use Loctite® Red on all bolts and tighten to the recommended specifications.
3. **It is the owner's responsibility to hook up all towing equipment per manufacturer's instructions/recommendations.**
4. Remove the attachment tabs when not in use (if applicable).

Notice To Baseplate Installer

1. It is YOUR responsibility to watch for:

- Oil cooler and air conditioner lines
- Electrical wires and hoses
- Missing parts or attaching points on the frame

** If the baseplate is improperly installed and is against a wire or hose, it could cause fluid leaks or electrical shorts some time after the actual baseplate installation.

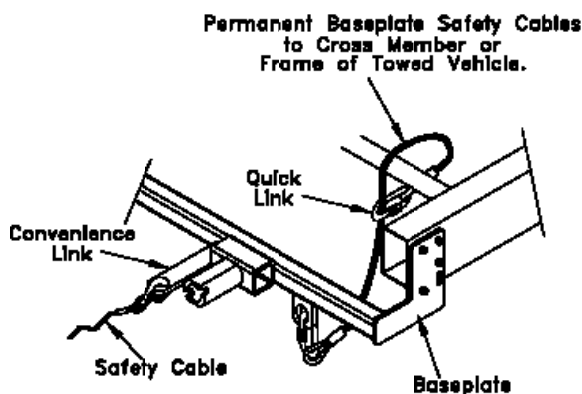
Permanent Baseplate Safety Cable Installation

Permanent baseplate safety cables are strongly recommended when towing a vehicle with a tow bar. The principle function of the permanent baseplate safety cables is to prevent the towed vehicle from breaking loose in the event the connection between the frame of the towed vehicle and the baseplate fails or becomes disconnected. The cables must be connected from the baseplate to the frame rail or cross member of the vehicle's frame. The illustrations below show the possible arrangements recommended by Blue Ox®. Each permanent baseplate safety cable must have an adequate weight rating for the towing system. The weight rating of the two (2) cables together will not qualify.

Do not mount the permanent baseplate safety cables against wires, hoses or brake lines.

These permanent baseplate safety cables should remain installed as long as the baseplate is installed on the vehicle. Permanent baseplate safety cables are to be used in conjunction with, and NOT a replacement for legally required safety cables attaching the towed vehicle to the towing vehicle.
