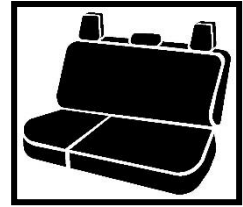

CUSHION COVERS

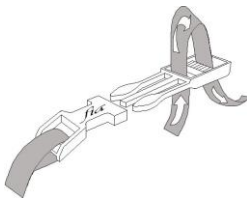
1. Center cover on seat
2. Lift cushion to halfway up position and pass back flap through crevice
3. With cushion in up position locate straps and buckle to back flap
4. smooth out cover and adjust straps to equalize tension for a better fit

BACKREST COVERS

1. Ensure cover is installed under seat belt strap
2. Place cover over backrest. Cover has allowance to fit over headrest. (see notes)
3. Undo Velcro and place around headrest post to reduce cover movement during installation. Tuck material behind the seat for better fit.
4. Pass side Velcro behind the seat and attach to the bottom of cover
5. **DRIVERS SIDE.** Pass center strap through opening on metal seat belt base on floor and buckle
6. **PASSENGER SIDE.** Anchor each center strap on metal seat belt base on the floor and buckle
7. Smooth out cover and adjust straps/velcro to equalize tension for a better fit.

2) FOR DT72-67 INSTALLATION

Undo Velcro on cover, place around headrest post and attach.
