





HITCH WEIGHT: 30 LBS. INSTALL TIME

PROFESSIONAL: 30 MINUTES NOVICE (DIY): 60 MINUTES

- **INSTALL NOTES:**
 - NO DRILLING REQUIRED
 - LOWER SPARE
 - LOWER EXHAUST

INSTALLATION STEPS

- 1) Lower spare tire for ease of installation. (Replace later)
- 2) Lower exhaust by removing (3) bolts from exhaust hanger bracket as shown. (Re-use later)
- 3) Remove the lower (2) bumper bracket bolts on both side of vehicle as shown. (Discard) (NOTE: DO NOT REMOVE TOP BOLT)
- 4) Raise hitch into position over exhaust and secure with M12 hex bolts and conical washers, finger tighten.
- 5) Install remaining M14 hex bolts and lock washers through hitch and bumper bracket as shown.
- 6) Reinstall exhaust hanger bracket removed in step 2.
- 7) Torque all M12 fasteners to 86 lb-ft and all M14 fasteners to 136 lb-ft.
- 8) Reinstall spare tire lowered in step 1.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
