

## CARE AND USE INSTRUCTIONS

Thank you for selecting a WeatherBeater<sup>TM</sup> Floor Liner from Winfield Consumer Products. Your new front floor liners are custom molded to fit your Toyota Prius c & Yaris. The liners are made to take the place of your factory floor mats. *For correct fit, it is necessary to remove the factory floor mats before installing your new floor liners*. However, do not remove the factory-installed carpeting.

Your liners are made from an engineering resin that is lightweight and extremely tough and durable. The easiest way to clean your liners is with a damp cloth or sponge. If using a cleaner, 409<sup>®</sup> or Glass Plus<sup>®</sup> work well. Use of Armor All<sup>®</sup>, Son-of-a-Gun<sup>®</sup> or similar items is discouraged as these products make the liners slick.

## INSTALLATION INSTRUCTIONS FOR YOUR TOYOTA PRIUS c / YARIS FRONT HUSKY LINERS® WeatherBeater<sup>TM</sup> FLOOR LINERS



LEFT OR DRIVER'S SIDE



RIGHT OR PASSENGER'S SIDE

TO EASE INSTALLATION OF YOUR FRONT LINERS, MOVE THE FRONT SEATS TO THEIR MOST REARWARD POSITION AND TURN THE FACTORY TWIST-LOCK MAT RETAINERS SO THE TOP HALF IS ALIGNED WITH THE BOTTOM HALF. WITH THIS DONE, INSTALL THE LINERS, MAKING SURE THEY ARE SECURED IN PLACE WITH THE TWIST-LOCK FASTENER. LASTLY, REPOSITION SEATS AS DESIRED.

TO ACCESS THE FUEL DOOR RELEASE LEVER IN YOUR VEHICLE WITH YOUR LINER IN PLACE, YOU CAN SIMPLY LIFT UP THE LINER OR YOU CAN TRIM AWAY THE MATERIAL LOCATED DIRECTLY ABOVE THE FUEL DOOR RELEASE AS SHOWN ABOVE. THE AREA TO BE REMOVED IS LOWERED, USE THE EDGES OF THE LOWERED SECTION AS YOUR TRIMMING GUIDE.

## **HUSKY LINERS PRODUCT WARRANTY**

Return alleged defective part to the place of purchase for replacement or refund. Please have a copy of your purchase receipt available when you call. The foregoing is the only express warranty made by the manufacturer and is limited to the duration of this warranty. ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE DURATION OF THIS WARRANTY. LABOR CHARGES, INJURIES, OR ANY OTHER LOSS OR DAMAGES WHATSOEVER, INCLUDING THOSE INCURRED IN INSTALLATION ARE EXCLUDED. ADDITIONALLY, PAINTING OF REPLACEMENT HUSKY LINER PARTS AND ANY VEHICLE COMPONENT REPAIR OR REPLACEMENT AS WELL AS INCIDENTAL DAMAGES ARE EXCLUDED.

This warranty is void for damages to the product due to misuse, abuse, neglect, accident, improper installation or any use that violates the instructions furnished by us.

**ABNORMAL WEAR AND TEAR ARE NOT COVERED UNDER THIS WARRANTY.** Obviously, if your dog chews up your Husky Liner product, it's not covered under the warranty. Likewise, if you shut your Husky Liner in the door of your vehicle, damage to the liner and/or door are not covered. Commonplace, everyday wear on a particular product is considered normal, and is not covered under warranty repair.
