



## MBRP Limited Warranty - 2023

MBRP Ltd. (hereafter “MBRP”) gives this Limited Warranty covering defects in material or workmanship, under normal use and service. This warranty is limited to the original user only, from the date of purchase for the time period shown below.

### **Powersports Warranty:**

All warranty claims are to be taken to the original point of purchase. MBRP warranty applies only to defects in materials and workmanship to the original purchaser on record providing that the installation was made on the original vehicle for which it was designed and tested.

The warranty period is limited to two years for snowmobile products and one year for ATV/ SXS products from date of purchase. The warranty does not include the cost of removal or reinstallation of the product, nor does it apply if the product has been damaged by accident, abuse, misuse or misapplication. MBRP’s sole obligation will be to repair or replace the unit at our discretion. Determination of warranty on any product is subject to inspection by an MBRP Quality Control Inspector. Due to the nature of our products and their intended usage, MBRP makes no warranties, either expressed or implied, regarding performance, safety, fit, merchantability or longevity for a particular purpose.

Purchasers are responsible for the selection of the appropriate and correct performance product and must rely on their own skills and judgement that such performance products are appropriate for their particular application.

### 1. Warranty Criteria Qualifications:

- 1) Your MBRP product must be purchased through an Authorized MBRP Dealer. You are able to verify that your dealer is authorized by checking our site at [https://mbrpautomotive.com/index.php?page=dealerlocator\\_adp?](https://mbrpautomotive.com/index.php?page=dealerlocator_adp?)
- 2) Your product must be registered within 30 days of purchase. You can register your purchase online at <https://store.mbrpautomotive.com/warranty/?page=warrantycard&agree=1>.
- 3) You must be the original owner of the vehicle on which the product was first installed.
- 4) This warranty does not include the cost of removal or replacement of the product.

- 5) This warranty shall be expressly limited to the repair or replacement of defective parts. All other damage and claims, statutory or otherwise, are expressly waived by you as purchaser.
- 6) This Warranty does not apply to:
  - a) Any product damaged due to poor installation.
  - b) Damage caused by abuse, misuse, or an act of God (such as a flood). Consequential and incidental damages are not recoverable under this warranty. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages and state, or provincial law will prevail.
  - c) Product that has been operated beyond MBRP's recommended capacity.
- 7) From time to time, manufacture of certain products is discontinued and replacement no longer possible. For such products, this warranty shall be limited to repair only. If, in MBRP's sole judgement, repair is not possible then this warranty shall lapse and be at an end.

2. If you wish to submit a warranty claim:

- 1) Call MBRP toll free (888-636-7223). Our customer support staff will assist you in proceeding with your warranty claim.
- 2) To qualify for the Limited Warranty, we must receive a copy of your receipt (untampered with or fabricated in any way) verifying purchase through an Authorized MBRP Dealer. We have the right to deny any warranty believed to be false, altered or purchased through an unauthorized dealer.
- 3) If there is a visible defect, you will be requested to send pictures of the affected part.
- 4) It is your responsibility to ship any MBRP product under a warranty claim to MBRP at your expense. MBRP will cover all Fed Ex ground charges (within the continental United States and Canada) to ship product back to you. Any expedited or additional shipping charges will not be covered by MBRP and will be your responsibility.
- 5) Product shipped to MBRP under a warranty claim must show the RMA number that we will provide marked on the shipping documentation. NOTE: If repairs are sent in without an RMA number, an additional charge of \$25.00 will be applied even if the product is found to be under warranty.
- 6) If any product is submitted for warranty but does not show any warranty issue the product will be returned but you will be responsible for any shipping cost. Alternatively, the product will be destroyed.

**Because sound is subjective, we do not warranty for sound. There are usually several ways to adjust the sound of your exhaust kit. Please contact your dealer or MBRP directly to discuss these options.**

**Tip Maintenance: Your 304 mirror polished stainless steel tips are not a maintenance free product. For best results – use a chrome polishing or stainless steel cleaner to maintain the shine and reduce rust. Warranty on this product and MBRP black coated tips covers defects in the material and workmanship only, and does not extend to pitting, stone chips or other damage. MBRP recommends the use of mud flaps and encourages regular cleaning and maintenance to assist with reducing any changes to appearance due to road treatments.**
