8.2. Exposure controls

Appropriate engineering controls

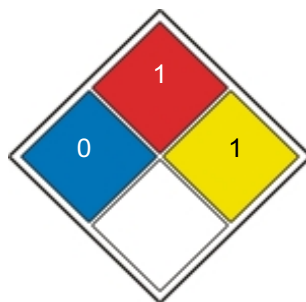
